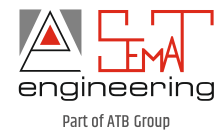

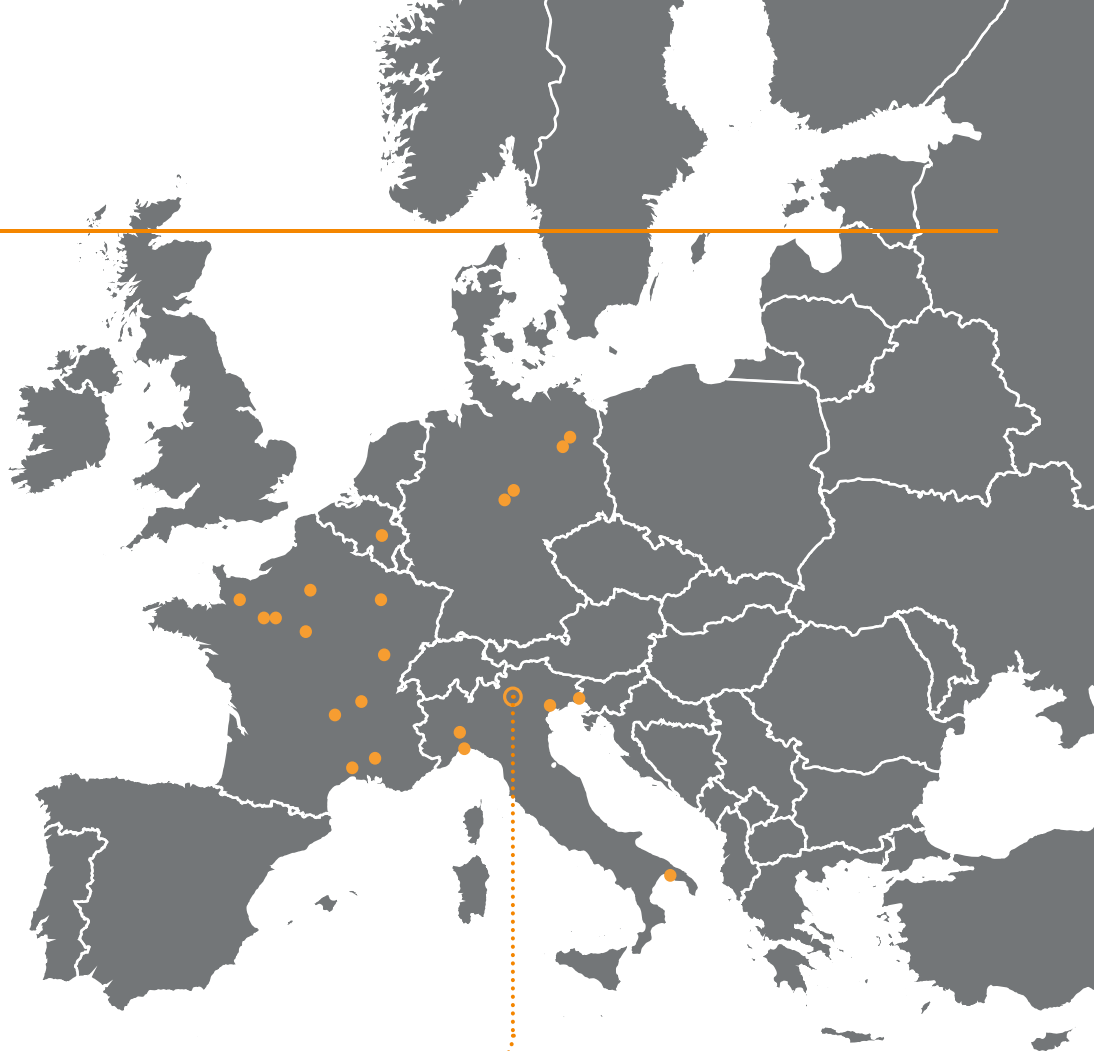

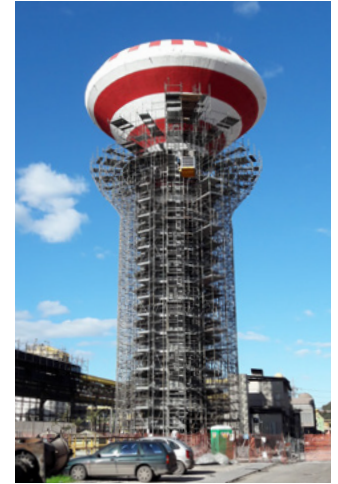

Semat manages operations on all phases of the production cycle and even in those parts of plants that are difficult to reach by humans, for example, under belt conveyors or the furnaces themselves.

The main services offered are:

- Short-stop revamping activities;
- Industrial Services and asset management;
- Transportation and logistic;
- Mechanical and refractory maintenance of main and drain runners (slag/pig iron), tilting, spouts and hot air ducts, casting areas and piping platform, torpedo ladle, ladles, blast furnaces, and coke ovens;
- Maintenance on slag condensation systems civil structures and related storage tanks;
- Maintenance and servicing of the furnace cooling water collection and treatment system;
- Revamping and installation of the refractory lining of electric and gas casting furnaces for steel processing;
- Demolition and reconstruction of tundishes refractory linings for rolling mill and heat treatment furnaces;
- Regulation of coke oven gates;
- Replacement of the hot air outlets and reconstruction of runners which are subject to increased wear;
